The **Forest Voluntary Action Forum** and the **National Centre for Creative Health** are looking to recruit a young person (aged 18 – 24) with lived experience of mental health issues as an Event Assistant on a part time basis for a period of three months. The Event Assistant will support with the design and delivery of 'A Heart Shaped Place', an event delivered in partnership with **Gloucestershire Clinical Commissioning Group, Barnwood Trust** and **Forest Voluntary Action Forum**. The event's purpose is to showcase co-production and how it can be used to change mental health service delivery in the Forest of Dean. It will take place in July, marking the culmination of a research and scoping project that aims to kickstart the co-production of a new community based mental health service in the Forest.

The part-time role would be ideal for a young person who has used creativity in their own recovery journey, and is interested in gaining some experience in working in the arts.

Job tasks will include:

- Creating an event programme
- Communicating with speakers and facilitators
- Booking refreshments
- Writing social media posts about the event
- Staffing the event
- Taking bookings and communicating with event guests

Person specification:

We are looking for a young person aged between 18 and 24 with their own lived experience of mental health issues for this role. Although not essential, the following skills and experience are desirable for the role:

- Experience of organising an event (this could be outside of employment)
- Good communication skills, both written and verbal
- An organised self-starter
- Computer literate (able to competently use Microsoft Office software)

- A positive and flexible attitude
- Experience / interest in using the arts for mental health recovery
